

## **EYNESHAM CARNIVAL CONDITIONS OF ENTRY 2018**

Entries and full payment must be received not later than 1st June, 2018.

Outside exhibitors must apply and pay for sufficient space to take in all stakes and guy ropes required for any building, tent or marquee to be erected on the space.

The excavation of soil or removal of turf for the erection of surrounding fencing and other structures will not be permitted.

The Committee shall determine the area and position on the showground to be allotted to the exhibitors.

The Committee reserves the right to refuse any application or reject any exhibit if, in its opinion, the purposes of the application are contrary to the spirit of the Carnival.

The Committee has decided that exhibits of a political nature or relating to controversial topics concerning Eynsham and its environs will not be permitted.

No alcoholic beverage may be sold or offered as a prize due to licensing regulations.

No exhibitors may sub-let the whole or any portion of any space allotted to him/her under penalty of cancellation of his/her site.

Exhibitors must remove all his/her exhibits rubbish created from the showground.

The Committee shall not be responsible in respect of any loss or damage arising from any error in the apportionment of space on the showground, or from any encroachment by one exhibitor on the space apportioned to another.

A pass, admitting one vehicle and up to two stallholders to the showground, will be issued free to each exhibitor.

Vehicles will not be permitted to the showground after 11.30am and vehicles not within the allocated space must be removed from the showground by 11.30 am to the Stallholders Car Park.

No exhibitors will be allowed to place his/her exhibits, hoards or placards of any description so that any part thereof projects beyond the limits of the space allotted to him/her, nor in such a manner as to obscure unduly the signs of adjacent exhibitors stands and the Committee's officials and officers are empowered to remove from the showground any articles placed in contravention of this rule.

All goods, exhibits, vehicles, temporary buildings etc. must be removed from the showground before 8pm on Carnival Day. The Committee reserves the right to remove and store any goods or exhibits that is not removed by that time. Neither the Committee nor its servants, agents and contractors shall be held liable for any loss or any damage arising from exercise of this right, and the exhibitor shall be liable for payment of all costs and expenses incurred by the Committee in connection with the exercise thereof. Stallholders are responsible for clearing their sites of all litter etc.

No exhibitor may light a fire for any purpose whatsoever.

The Committee may exclude in their absolute discretion and without giving any reason or explanation, any person, firm or corporate body from the showground who, in the opinion of the Committee, has infringed the Committee's regulations or has been guilty of dishonest or unfair conduct either at or in connection with the Carnival.

The entire risk and responsibility as regards the exhibits of each exhibitor and in reference to all consequential or other injury, damage or loss arising there-from or thereto, shall be borne by the exhibitor.

The Carnival Committee will not, in any way, be responsible for any claim or compensation or otherwise in regard to the holding, or for anything arising out of or connected with the Carnival.

The Committee will not be responsible for any accident that may occur from any equipment belonging to any exhibitor and it is a condition of entry that each exhibitor shall hold the Carnival Committee harmless and indemnify it against any legal proceedings, action, costs, claims, expenses and demands arising from any accident caused by his/her equipment.

The Carnival Committee delegate full power to members of the Committee to enforce all regulations of the Carnival.
